Christian Broda (Ph.D., MIT) is a Managing Director at Duquesne Capital Management. Prior to joining Duquesne, he has served as a Professor of Economics at the University of Chicago. He has published numerous articles and books on international finance and trade. His research has been published in top economic journals like *the American Economic Review* and *the Quarterly Journal of Economics*, and has been featured regularly in the press. In 2005 and 2008, he was awarded two National Science Foundation (NSF) grants to support his research and he was named the James S. Kemperer Scholar in 2006.

Dr. Broda also served appointments at Lehman Brothers as Chief International Economist, Barclays Capital as Head of International Research, Columbia University and the Federal Reserve Bank of New York. He is also an associate editor of the *Journal of Development Economics*, a faculty fellow for the *National Bureau of Economic Research*, a co-editor of the *IMF Economic Review* and a member of the *Latin American Association Economía* journal.
